

National Ocean Policy: Timeline

- June 2009 President Obama established the Interagency Ocean Policy Task Force
- July 2010 Executive Order 13547 signed; adopted the Final Recommendations of the Task Force and established a National Ocean Policy
- 2011 through 2012: Scoping meetings and public comments on the Draft Implementation Plan
- April 2013 National Ocean Policy Implementation Plan released
- July 2013 Marine Planning Handbook released

Benefits of the National Ocean Policy & Implementation Plan

Improves interagency coordination to:

- Provide more efficient Federal permitting
- Better manage the ocean, coastal, and Great Lakes' resources that drive much of our economy
- Develop and disseminate sound scientific information for local communities, industries, and decision-makers
- Collaborate effectively with State, Tribal, and local partners, marine industries, and other stakeholders



Implementation Plan & Highlights

1. The Ocean Economy

- 41% GDP generated in shoreline counties (\$6 Trillion in 2010)
 - Highlight: National Shellfish Initiative / improved permitting process



2. Safety and Security

- Improving maritime domain awareness and safety and security
 - Highlight: Arctic ice forecasts
 - Highlight: Navigational safety

3. Coastal and Ocean Resilience


- Reduce adverse conditions / prepare for change / ocean health
 - Highlight: Guidance on the use of regional climate and sea-level rise scenarios
 - Highlight: Reduce coastal wetland loss



4. Local Choices

- Tribal, State, regional, local
 - Highlight: Local & traditional knowledge / integration
 - Highlight: Marine planning Regional Planning Areas / Bodies

Nine Regional Planning Areas



Four Regional Planning Bodies

- In 2013, four Regional Planning Areas established Regional Planning Bodies (RPBs):
 - Northeast
 - Mid-Atlantic
 - Pacific Islands
 - Caribbean
- Each RPB is working toward a marine plan, organizing their path transparently, and providing ongoing opportunities for public input

- Decisions based on sound science
- Highlight: 2013 updated Federal Oceanographic


Fleet Report

- 47 ships
 - Measure and project global climate change and ocean acidification
 - Ensure buoys / sensors are in place for hurricane and tsunami warnings
 - Enable safe transportation
 - Conduct resource assessment


